FINANCE COMMITTEE MINUTES

Mr. Lamb discussed the Professional Services Review Timeline further with the Finance Committee. This review timeline allows us to be aware of what services are being provided by industry professionals and when they are reviewed or put out to bid. Discussion ensued. DISCUSSION ITEMS

7.1. Solar Array Field Project (Oral)

Mr. Lamb presented. Mr. Lamb will give a full presentation at the special Board of Trustees meeting tonight. He thanked Mr. Litwiller, Mr. Swanson, Ms. Davis, and Mr. Bishop for their hard work and contributions to this project. There are a variety of credits and incentives from multiple sources, including the State and Federal governments and Ameren. This is a \$3.4 million project

(including 10% contingency for both construction and non-construction) and would cost Heartland nothing out of deferred maintenance as this can come out of the Agriculture Complex energy credit. Ms. Hughs also recently submitted for further credit from the Agriculture Complex solar panels. An ITB (Invitation to Bid) process was followed for this. The main three bids were from Halo Solar, LLC; SunPeak, LLC; and Verde Solutions. Halo Solar was the winning bid and this bid would allow the College to make money on this project due to the energy credits. Discussion ensued, focusing on locality, timeline, maintenance, energy sustainability, and cost.

Mr. Whitt moved to recommend the Solar Array Field project as presented; Mr. Crockett seconded, and the motion was approved.

ADJOURNMENT

Mr. Whitt moved to adjourn the meeting of this august body; Mr. Lamb seconded, and the motion passed.
